Horse substitutions can only be made if the original horse in the run is vetted out and the office is notified 1 hour before class. Horses will not be swapped from one run to another as this is considered "picking your draw positions." Rider substitutions can be made as long as the office is notified at least 1 hour before class.

If you are "buying out" another person's run, all money exchanges for the buyout must be handled between riders, and the original rider must be the one to notify Tri-K of the substitution. These buyouts must be completed at least 1 hour before class, or the original rider will be considered a scratch.

Medical Releases/Vet Outs will be allowed refunds for jackpot portion only if drawn out before pre-entry draw is posted on Saturday, 1week prior to each event. Tri-K Barrel Race will retain office charges, processing fees and late fees per entry.
