# **Terms & Conditions**

# 1. ANCILLARY ENTRIES

Close at noon the day prior. Late entries will be accepted up until 5pm day before class with a \$25 late fee. Late entries will go in order determined by show management.

#### 2. DERBY ENTRIES

Open Derby closes Friday at NOON, and Non Pro Derby closes Saturday at NOON. Derby will be drawn at noon the day prior. After the draw, any additional late entries will go first in their own section. Late entries will be accepted up until 5pm day before class with a \$50 late fee.

#### 3. PAID WARM-UPS

Paid warm-ups are available on Wednesday, May 10th from 9am – 7pm for \$35. Warm-ups are limited to 7 minutes per person.

# 4. REFUNDS

Ancillary entries, if scratched prior to draw, will be refunded all entry fees. No refunds for ancillary entries after the entries close (draw is complete).

#### **GENERAL EVENT CONDITIONS**

# 1. STALLS

Stalls will be available starting Tuesday, May 9 at NOON for a fee of \$125/ stall for the duration of the Event or \$45 per night. All horses on grounds overnight must purchase a stall. Shavings will be sold at the current industry rate of \$9 per bag. Stall Office Hours are: Tuesday Noon to 10pm, Wednesday and Thursday 7am – 10pm, Friday and Saturday 7am – 7pm. Horses choosing not to stall will be accessed a \$45/per day haul-in fee. Book at openstalls.com

#### 2. RV HOOKUPS

RV Hookups will be available starting Tuesday, May 9 at NOON, for a fee of \$35 per night for Arena location hookups, \$50 per night for Arena Full (includes sewer) hookups, and \$45 per night for Stall location hookups. All hookups include 50 or 30 amp electricity and water.

# 3. JUDGES

All decisions of the judges are final. The event judges will be Gary Putman, Doug Milholland and Marilyn Peters.

#### 4. ARENA HOURS

The indoor arena will be available for open riding anytime the show is not in session. The Arena will close 1 hour prior to the show start time daily.

#### 5. DAMAGE

Individuals will be responsible for any physical damage inflicted to Lazy E property and will reimburse the show management for such damage.

#### 6. HEALTH REQUIREMENTS & CERTIFICATES

Health requirements for the State of Oklahoma will be followed (30-day health certificate and 12-month coggins).

#### 7. RULES/CHANGES

The show management reserves the right to interpret these rules and regulations. All decisions will be final. By way of making an entry, the exhibitor is assuming responsibility for knowledge of the rules and releases show management from any claims or losses. The show management reserves the right to modify or change conditions and schedule for the Lazy E Red Dirt Reining Event.

# 8. RIGHT TO CANCEL

The show management reserves the right to cancel the event without notice at any time prior to the contest and without liability to the show management. In the event of such cancellation, entry fees or other show fees paid in advance shall be refunded. The show management reserves the right to interpret all questions and conditions in regard to, or arising out of, or incident to, the show without claims for damages or recourse of any kind. All questions not covered in these rules and regulations shall be decided by show management, its decision to be final.

The show management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, deny access to property, remove from property and cancel award prizes, without claim for damages.
